Analysis Report


1. 41% of students have considered the value of learning in teaching in college as very good while 38.4% students have considered it good and 20.44% students have considered it satisfactory.
2. 42% of students have considered it very good in terms of completion of college course and 30.7% have commented as good while 27.3% students have considered it satisfactory.
3. 43.6% of students have considered it very good in terms of learning outcome in daily life and 36.4% students have said it is good while 20% students have commented as satisfactory.
4. 72.7% of students have considered the ease of use of teaching aids in teaching in college as very good while 18.2% students have said it is good and 9.1% students have commented as satisfactory.
5. The efforts made to meet the needs of the students have been commented as very good by 37.38% students, good by 32.36% students and satisfactory by 5.62% students.
6. The overall learning evaluation of the college has been rated as very good by 32.36% students, good by 63.47% students and satisfactory by 4.17% students.

2. 50% of the alumni have praised the fee structure of the college, while 33.3% said it was good and 16.7% of the students found it satisfactory.
3. Regarding the academic environment of the college, 50% of the students have said it is very good and 50% of the students found it good.
4. Regarding the basic facilities of the college, 33.3% of the alumni have said it is very good and 66.7% of the students found it good.
5. In the feedback related to the number and curriculum of the college, 57.3% of the alumni have said it is very good, while 36.5% found it good and 6.02% of the alumni found it satisfactory.

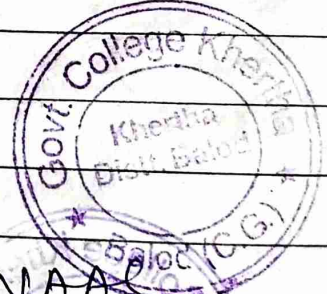

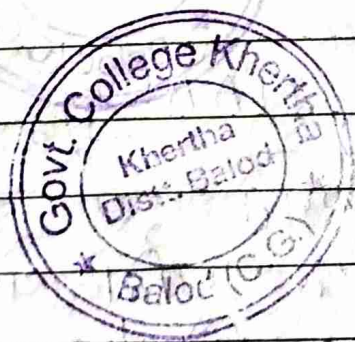

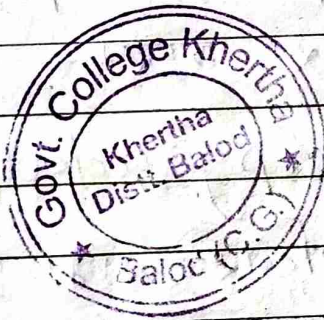
